




THE ECA

Under the provision of Environmental Protection Act 1995, the Government of Bangladesh declared 10 km landward periphery of the Sundarbans as Ecologically Critical Area on 30 August 1999. A total area of 2,929.26 sq. km is identified as ECA according to the Gazette Notification.

DOE estimated the number of industries and factories are 190 (149 in operation) while independent researchers found more than 320 factories in the adjacent areas of the Sundarbans. The DOE Report itself marked 32 factories as highly polluting for the environment. Cement Factory, LPG Plant, Oil Refinery, Brick Kiln, Shipyard, Tobacco, Automobile, Rice mill, Sawmill, Repairing Garage fall under RED category.


RAMPAL COAL POWER PLANT

Rampal Power Plant's carbon emissions to adversely affect Sunderbans: HC

Sunderbans in Bangladesh will definitely be adversely affected by huge carbon emissions from the coal-fired power plant, the High Court Division said on Tuesday without mentioning the under construction Rampal Power Plant.

A bench of Justice FRM Nazmul Ahasan and KM Kamrul Kader made the remarks while delivering a verdict in which the Department of Environment directed to give the clearance for setting up Baraka LPG Bottling Plant at Mongla, Bagherhat.

Surprisingly, the respective agencies (Department of Shipping, MPA or FD) failed to identify the responsible companies for the sinking vessel in 1990 and 1992 The Indo-Bangla transshipments have been going through Sundarbans now. Already 9 ships capsized in last 5 years with Coal Fly Ash. A group of Indian fishermen have already filed a case in the Green Tribunal

- Serious level of river erosions are observed in the Passur and Kajibachha river due to unplanned sand mining.
- Sensitive fishes are almost absent in upper Passur river due to pollution and increased temperature of water.
- As a wetland, these unplanned construction of industries have serious impact on water channels.

Asian Water Outlook marked Bangladeshi rivers as most polluted among 48 countries in Asia. Bangladesh ranked 162 out of 180 countries in Environmental Performance and 124 in River Water Quality Index.

LAND GRABBING

- Most of the lands are taken bypassing Acquisition and Requisition Act 2017. In these cases, the lands have been purchased at individual level by using local powerful persons, and then transferred to the company.
- The factories are established on cultivable lands violating Agricultural Land Protection and Utilization Act 2018. It also violated the Notice of the Ministry of Land on 26 November 2012.
- 11,368 acres of agricultural land have been lost in last 10 years although the districts of Bagerhat, Khulna and Satkhira have been experiencing food deficit since cyclone Sidr in 2007

Interestingly, none of the companies have been faced any administrative barrier to do these illegal deals.




COASTAL ZONE POLICY



- Zoning regulations will be established for location of new industries in consideration of fresh and safe water availability and effluent discharge possibilities;
- All industrial units will be required to install built-in safeguards against pollution within a given timeframe.
- Polluting Industries will be required to pay "green tax" for cleanup of the environment polluted by them.

ECA RULES

- Any activities which could affect the Ecologically Critical Area (ECA) negatively is prohibited and treated as a punishable offence (Section-18, ECA Rules 2016)
- Sand lifting from any site which is declared as ECA under the Bangladesh Environment Protection Act (BEPA) 1995 is totally prohibited (Section 4(A), Balumahal and Soil Management Act 2010)



WALKING BACKWARDS!

- LPG Bottling Plant and LNG Terminal was categorized as RED in Environmental Protection Act 1995 and its amendment in 2010. Suddenly, the Department of Environment (DOE) re-categorized the LPG Bottling Plant as "Green" in June 2017.
- As a result, these highly explosive and environmentally risky industry doesn't need any Initial Environmental Examination (IEE) or Environmental Impact Assessment (EIA) and also allowed to establish within any ECA.



HIGH COURT ORDER



The High Court Division ordered to stop constructing anymore factories in the Sundarbans Ecologically Critical Area (ECA) on 23 August 2019.

But the order is violated seriously and construction work of Dipon Group still going on...

Scrap Rampal Coal Power Plant

The Government already has decided to stop second phase of Rampal Coal Power Plant and install a solar power plant in that place. It is time to scrap the Phase-1 also and convert it to Soar Plant.




Demarcate the ECA

Demarcate the exact Ecologically Critical Area (ECA) and put Cautionary Signal or demarcation signboard as a public notice so that everybody can understand the obligations.

Ecologically Critical Area AHEAD

Any type of Industrialization is prohibited and treated as punishable offence. Be responsible to protect the ECA.




Disclose the EIA Reports

Disclose the IEE and EIA Report in public so that affected communities and concerned citizens can express their opinions to the project proponents and respective authorities

Form EIA Assessment Panels

There should be an independent Expert Panel to assess the EIA Report as the process of approval becomes a mere formality due to biasness and influences.






Ensure Proper Monitoring


- Environmental Clearance must be taken from both the Local offices and Head office of Department of Environment (DOE) to ensure double checking of the documents and reduce influences.
- Adequate staff allocation for DOE with sufficient equipment and Green Court at Divisional Level.
- Closely and regular monitoring the air, water and noise pollution in the Sundarbans adjacent areas.

Form a Oil Spill Striking Force

Formation of a Striking Force with Participation of Department of Shipping (DOS), Forest Department (FD), Fire Service & Civil Defense (FSCD), Coast Guard, Bangladesh Inland Water Transport Authority (BIWTA), Mongla Port Authority (MPA), Department of Environment (DOE) and Expert Members.







Include whole area in SEA Process

Include areas of Barisal, Patuakhali and Barguna Districts in the on-going Strategic Environmental Assessment (SEA) process as the water flow from these areas has significant influence on the Sundarbans.
